Legislative Session a Busy Place

Recently the Capitol was a busy place. A number of bills were introduced, some effecting active state employees and one in particular effecting retirees.

That bill is SB 175, sponsored by Sen. Jeffrey Schoenberg would require state retirees and survivors to pay a portion of their health insurance premiums. In sponsoring the bill, Sen. Schoenberg used a report completed by a consulting firm Mercer, one which gave data on such charges from other states as well as private industry.

The ISEA Retirees coalition (with State Universities Annuitants Association and Retired State Employees Association) met with Sen. Schoenberg on two different occasions and Senate President Cullerton, and minority leaders Rep. Tom Cross and Sen. Christine Radogno. The group also met with Rep. Patricia Bellock who is sponsoring the bill in the House.

After listening to our concerns the bill was not called for a vote and the sponsors have pledged to have it ready for the fall session. Both sponsors have indicated that they would again discuss this bill with us before the fall session. We are planning several meetings this summer with legislators concerned about the contents of this bill.

News from the Insurance Department

We have received many calls regarding Benefit Choice Period and the choices and changes that are available. As you are aware, this year has been particularly confusing.

If you have had the Quality Care Health Plan, administered by Cigna, there are no changes that need to be made at this time.

The members that have Managed Care Plans must be aware and possibly ready to make a choice at the next enrollment period if they intend on changing plans. The Managed Care Contracts for Health Alliance HMO, Health Alliance Illinois, HealthLink OAP, PersonalCare HMO and PersonalCare OAP have been approved for 90-days. The dates have not been decided for a special enrollment period but will be posted on this website and www.state.il.us.

The above options are in addition to HMO Illinois, BlueAdvantage HMO and the Quality Care Health Plan (administered by CIGNA), which will not change.

A member recently asked me to describe coordination of benefits if a person has Medicare, Parts A and B and (for example) the Quality Care Health Plan. Medicare is the primary carrier, who considers the claim initially. If they pay (80% of the approved amount), the claim is forwarded to Cigna for consideration. Cigna typically pays the balance due (the remaining 20%). For an in-hospital stay, there is a \$50.00 deductible which is the patient's responsibility. Typically, there are no out-of-pocket expenses for the patient on Part B charges. Of course, there are always exceptions to this rule, but this is the way most claims are handled.

Delta Dental is the new plan administrator for the dental program effective July 1, 2011. The benefits and monthly premiums have not changed. You can choose any dentist that you wish but in most cases, you can reduce your out-of-pocket expenses by utilizing a network provider. See page 22 in the current handbook for network details.

Prescription Drug Step Therapy (PDST) is a program which is meant to encourage members to select lower cost (generic) drugs before choosing the higher cost (preferred and non-preferred) equivalent. If a participant chooses a preferred or non-preferred and a generic is available, the participant must pay the cost difference between the brand product and the generic product, plus the generic co-payment.
